Another Great Show is a registered Thoroughbred stallion, approved for breeding with the Jockey Club by Live Cover. He is also registered with AQHA for the purpose of registered appendix foals. It is the *Mare Owner's* responsibility to verify the foal's eligibility for registration, and to fulfill the requirements of that registry.

Fees & Specifications:

1. Nonrefundable booking fee of \$200.00 USD, due with the signing of this contract.
2. A service fee of \$400.00 USD, which is the balance of the \$600.00 USD stud fee, Payable prior to mare being serviced or semen being shipped.
3. Mare care of \$7 USD per day, and any other expenses (i.e. farrier, vet, special medications) incurred during mare's stay, payable upon mare leaving farm. **The Links** reserves the right to place mare in a stall, pasture or paddock, or a Combination of these; *Mare Owner* is responsible for supplying mare's feed.
4. A collection fee of \$200 USD is due prior to each shipment of cooled semen.
5. A shipping fee of somewhere between \$60-\$100 is due prior to each shipment of cooled semen, using FedEx Overnight, disposable containers will be used and all we require is you return them to us within ten days in order to avoid a container fee. (\$50 USD surcharge for Saturday delivery, or First Overnight).
*Shipping fee is subject to increase, with increasing FedEx tariffs.

We accept Check/Cash. If paying the stud fee and collection fee by Check please allow 10 business days for check to clear.

The Links reserves the right to determine if the mare will safely stand for a live cover. If she is determined not to be safe, or for any other reason, will not stand for live cover, the Mare Owner agrees to have **The Links** arrange to have the mare artificially inseminated, and will assume the cost of a collection fee of \$200 USD, and any fees associated with having the mare artificially inseminated.

Prior to breeding, the *Mare Owner* agrees to provide the following:

1. Documentation of a clean culture and cytology, performed by a licensed veterinarian.
2. Documentation of Rhinopneumonitis, Influenza, and Strangles vaccines, given within 2 months of mares coming to farm for live-cover.
3. A current negative Coggins Report, for mares coming to farm for live-cover. The *Mare Owner* also agrees that their mare has had Eastern & Western Encephalomyelitis and Tetanus vaccines, within the last year.

Live Foal

While the Breeder does not guarantee the mare shall get a live foal; the Breeder does agree that should said mare proven barren or the foal die at birth, the *Mare Owner* will send notice signed by a veterinarian within one week of such determination or death, and said *Mare Owner* shall be furnished breeding services the following season at no additional charge. The *Mare Owner* may rebreed the same mare. In the event the *Mare Owner* elects to exercise this rebreeding privilege, the *Mare Owner* agrees to pay normal and customary board fees and any fees from shipping/collection in effect in the following season. *Mare owner* agrees to give mare proper care during her pregnancy, to insure a healthy foal, including; vaccinating with Rhinopneumonitis (Pneumabort) at 5, 7, & 9 months of her pregnancy, implementing an acceptable de-worming schedule, feeding a proper diet, and keeping the mare current on her regular vaccinations (EWT & Flu). If this is not done, and mare fails to produce a live foal, the Live Foal Guarantee is null and void.

Hold Harmless

Mare Owner agrees to hold harmless and release *Courtney/Wes Sanders & The Links* and their respective agents, employees, representatives, assigns, affiliated persons, and/or others acting on their behalf from liability for ordinary negligence and any & all loss or damage relating to any and all injuries, damages, personal property damages or losses that *Mare Owner* may sustain arising out of the breeding, handling or keeping of their mare that may accrue from any cause whatsoever (including fire, theft, running away, accidents, illness, injuries or (death) during the term of this Agreement. In turn, *Courtney/Wes Sanders & The Links* agrees to give the same care, to this mare, as it does with its own horses.

The terms of this Agreement shall be governed by the laws of the State of Alabama.

Breach

Either party may nullify this Agreement if the other party breaches a material term of this Agreement
